Research

The NSGLC was one of four projects selected to receive funding from Illinois-Indiana Sea Grant to perform research on social and policy issues related to PFAS in the Great Lakes region. The Law Center will compile a list of all PFAS-related state laws and regulations in the Great Lakes and Lake Champlain regions and engage in comparative analysis of these policies. The Law Center will also develop case studies to further explore policy challenges. The research will help inform state regulators and lay the groundwork for regional consensus regarding PFAS policies. Read more about the other funded projects!

Funding

2024 Coastal Resilience Program Competition

The Law Center is accepting applications from eligible applicants to conduct research on the effectiveness of laws and policies related to a wide range of coastal resilience issues including sea level rise, flooding, amplified storm surge, increased frequency and intensity of storms, land use, or other environmental factors, and whether those policies are achieving desired policy changes. The 2024 Coastal Resilience Program grants have a recommended funding level of \$75,000, and the Law Center anticipates selecting up to two projects for funding. Matching funds will not be required.
