

2024 Coastal Resilience Program Competition

The Law Center is accepting applications from eligible applicants to conduct research on the effectiveness of laws and policies related to a wide range of coastal resilience issues including sea level rise, flooding, amplified storm surge, increased frequency and intensity of storms, land use, or other environmental factors, and whether those policies are achieving desired policy changes. The 2024 Coastal Resilience Program grants have a recommended funding level of \$75,000, and the Law Center anticipates selecting up to two projects for funding. Matching funds will not be required. 
